Practice Summary

Christoph regularly represents sellers or buyers in real estate transactions. His advice encompasses the "full set" of representation, starting with legal due diligence, drafting and negotiating real estate sale and purchase agreements (either in German or English and either as an asset or share deal) and culminating in post-closing matters.

He also advises landlords or tenants in connection with large commercial leases. He drafts and negotiates lease agreements and litigates lease disputes.

Christoph is qualified as a German Notary, specializing in real estate related notarial services, such as drafting, recording, and executing real estate sale and purchase agreements, agreements on hereditary building rights, and complex easements. In connection with the financing of real estate financing, this also covers the recording of land charges.
